2. Call Meeting to order – 6:30 pm
3. Larry Ekblad– Just Trees – extensive discussion regarding the trees – several items discussed:
 - a. Larry thinks that the area is overplanted
 - b. Discussed different types of trees that should be planted – Little leaf lindens, Redman Linden, Burr Oak, Sensation Maple
 - c. Best to plant the trees in spring
 - d. 1 ¾” caliper tree is better than 2” or larger – smaller caliper tree will catch up and exceed larger caliper tree
 - e. Establish a three year budget
 - f. Suggested that we prepare an inventory of all of the trees and where they are planted
 - g. Set up a maintenance plan

Board will review recommendations and get back with Larry. Rob and Randy will meet to start the inventory of the trees.
