2. Call Meeting to order – 6:30 pm
3. Review and Approve minutes – 6/10/15 – Amanda motion to approve, Ernie second, and the motion was approved.

peak; Rob seconded the motion; motion was approved. Randy made motion to approve the sidewalk; Ernie seconded the motion. Motion was approved.
