- 6. Previous Meeting Business
 - a. Pond/pump house update attended the Town Council meeting to respond to the letter that was received regarding the water issue. Council directed staff to work with the HOA.
 - b. TOJ Recreation Center project/park improvements TOJ Town Council will make a decision at the September meeting regarding the location of the recreation center. Because of the town center discussion the park improvement proposal has been postponed.

 - i. Trees are too close to each other. About 12 trees should be removed so that the other trees have room to grow. Trees on the south fence line are pushing under the fence. Rough estimate to remove the trees is \$350/tree. With stump removal the cost would be ±\$5,000. There are also several sprinkler heads that need to be moved and adjusted on the south end of CR 13. Motion was made by Rob to approve the removal of the trees and repair the sprinkler system; motion was seconded by Randy; motion was approved.
